A portion of the American Recovery and Reinvestment Act of 2009, widely known as the **HITECH Act**, the Health Information Technology for Economic and Clinical Health Act allows for incentive dollars to be distributed to eligible hospitals and providers that use "certified" EHR systems in a "meaningful way" via existing Medicare and Medicaid reimbursement systems.
